News Highlights

CSX Index

On 28 April 2025, the CSX index saw a decrease of 0.02%, closing at 409.28 points. Most stocks on the main board saw a decrease; only PEPC increased by 7.69%. Meanwhile, ABC decreased by 0.28%, GTI decreased by 0.28%, MJQE decreased by 0.47%, PPAP decreased by 0.85%, and PWSA decreased by 0.32%. CGSM, PAS, and PPSP had no changes. Over on the growth board, DBDE had no changes, while JSL increased by 0.95%. The total trading volume for the day reached 110,786 shares, with a trading value of KHR 666 million.

Kingdom's airports handle 1.96M air passengers in Q1

In the first quarter of 2025, Cambodia's airports welcomed 1.96 million air travelers, a 19% increase from the previous year, according to the State Secretariat of Civil Aviation (SSCA). Flights handled rose 19% to 17,434, and air cargo volume grew 10% to 17,147 tonnes. SSCA projects 7.5 million air passengers for 2025, up 20% from 2024, driven by more tourists, investors, better airport facilities, and expanded flight connections. Cambodia's airports now link to 34 cities in 12 countries through 31 airlines, with new international routes from Turkish Airlines, Etihad Airways, and Emirates. (Khmer Times)

Cambodia, Japan launch cross-border payment collaboration

The National Bank of Cambodia (NBC) and the Payments Japan Association (PJA) have signed an MoU to enable cross-border QR code payments between Cambodia's KHQR and Japan's JPQR systems. The cooperation will roll out in two phases: Phase 1 (early 2025) will allow Cambodians to scan JPQR in Japan, while Phase 2 (end of 2025) will allow Japanese users to scan KHQR in Cambodia. ACLEDA Bank and Sathapana Bank are designated by NBC, while NETSTARS will handle operations for PJA. The project aims to promote digital payments, boost tourism, simplify transactions, and support economic growth. This builds on a 2023 agreement between NBC and Japan's METI. (Khmer Times)

Cambodia, South Korea connect credit networks

Credit Bureau Cambodia (CBC) and Korea Credit Bureau (KCB) have launched the Cross-Border Credit Report Sharing Service, allowing financial institutions in Cambodia and South Korea to securely access verified credit histories across borders. This initiative aims to support more informed lending, especially for Cambodian workers in Korea and Korean citizens in Cambodia. Developed over several years, the service ensures data accuracy and regulatory compliance. It builds on a 2024 MoU signed during the Korea-Cambodia Business Forum. Leaders from both bureaus highlighted the service's role in promoting financial inclusion, regional cooperation, and broader access to credit. (Khmer Times)
