News Highlights

CSX Index

On 28 May 2025, the CSX index saw a decrease of 0.05%, closing at 406.27 points. The main board saw mix results; PAS increased by 0.50%, and PPAP increased by 1.94%. Meanwhile, ABC decreased by 0.29%, GTI decreased by 1.22%, PPSP decreased by 0.93%, and PWSA decreased by 0.32%. CGSM, MJQE, and PEPC showed no changes. Over on the growth board, DBDE had no changes, while JSL increased by 1.14%. The total trading volume for the day reached 124,715 shares, with a trading value of KHR 495 million.

Government to introduce debt securities to fund infrastructure projects

The Cambodian government is set to introduce infrastructure debt securities, enabling public and private infrastructure companies to raise capital through bond issuance for various development projects. The Securities and Exchange Regulator of Cambodia (SERC), with support from the Cambodia-Australia Partnership for Resilient Economic Development (CAPRED), has drafted regulations outlining the conditions and procedures for issuing these bonds. Approved by Deputy Prime Minister Aun Pornmoniroth, the drafts comprise seven chapters and 25 articles, aiming to ensure transparency and accountability. According to SERC Director-General Sou Socheat, the initiative diversifies investment opportunities and financial instruments available in Cambodia's securities market. Cambodia requires around \$36 billion for infrastructure projects from 2023 to 2033. So far, \$368 million has been raised via corporate bonds and \$158.85 million through government bonds since 2022. The bond market plays a growing role in Cambodia's capital market, rooted in collaborations with the Korea Exchange since 2006, culminating in the establishment of the Cambodia Securities Exchange (CSX) in 2010. Senate President proposes direct flights between Moscow and Cambodia

Cambodian Senate President Hun Sen has requested Russia to establish direct flights to Cambodia to strengthen bilateral ties, enhance tourism, and promote people-to-people exchanges. The request was made during a meeting with Russian Prosecutor General Igor Krasnov in Phnom Penh. Hun Sen praised the growing Cambodia-Russia relationship across legislative, executive, and judicial sectors and expressed hope for deeper cooperation in law enforcement and justice. He also emphasized the importance of boosting trade, investment, and human resource development, and extended an invitation to Dmitry Medvedev to visit Cambodia. Krasnov reaffirmed Russia's appreciation for the longstanding friendship, highlighting recent legal cooperation agreements and training initiatives. He pledged to forward the direct flights proposal to Russian leadership and expressed optimism about future travel and tourism links. (Khmer Times)
