CSX Index

On 5 June 2025, the CSX index saw an increase of 0.26%, closing at 407.71 points. Most stocks had no changes; except for ABC which increased by 0.29%, CGSM increased by 0.41%, and PEPC increased by 1.49%. GTI decreased by 1.00%. MJQE, PAS, PPAP, PPSP, and PWSA showed no changes. Over on the growth board, both DBDE and JSL had no changes. The total trading volume for the day reached 70,089 shares, with a trading value of KHR 433 million.

Economic and Business News

Cambodia's milled rice exports up 13.7 percent in first five months

Cambodia exported 344,199 tonnes of milled rice in the first five months of 2025, a 13.7% increase from the same period in 2024, earning \$252.3 million (up 15% $\,$ year-on-year). The rice was exported to 63 countries via 48 licensed exporters, with major markets being Europe, China, ASEAN, and other regions. Fragrant rice made up 75% of exports. Additionally, 3.1 million tonnes of paddy rice were bordertraded, generating over \$740 million in revenue. The Cambodia Rice Federation (CRF) aims to export 1 million tonnes of milled rice by 2025. The government has allocated \$150 million to support rice millers in purchasing paddy from farmers.

MISTI, Daikin sign MoU to improve air conditioning standards in

Cambodia's Ministry of Industry, Science, Technology, and Innovation (MISTI) has signed an MoU with Daikin Airconditioning (Cambodia) Co., Ltd. to enhance HVAC standards and promote sustainable technologies in the sector. The agreement focuses on technical support, capacity building, and adopting energy-efficient and environmentally friendly HVAC solutions, aligning with international standards and Cambodia's climate goals. The signing was attended by Minister Hem Vanndy and senior Daikin executives. Both parties emphasized the partnership's role in improving energy efficiency, supporting industrial development, and contributing to Cambodia's sustainable future. (Khmer Times)

ABA Bank Welcomes Canadian Delegation as Part of Regional Trade

On May 30, 2025, ABA Bank hosted the Team Canada Trade Mission at its head office in Cambodia to showcase its impact on the country's financial sector. Led by Sara Wilshaw, Canada's Chief Trade Commissioner, the delegation met with ABA CEO Askhat Azhikhanov and representatives from the National Bank of Canada. ABA presented its journey to becoming Cambodia's largest commercial bank, emphasizing its role in expanding financial services, promoting financial inclusion through its mobile app, and enhancing IT and cybersecurity infrastructure.
